# 2014 Division 3 Conference Minutes O'Fallon, IL March 27 – March 29, 2014

The Division 3 Annual Conference was held March 27-29 at the Holiday Drury Inn & Suites, O'Fallon, Illinois; it was hosted by Chapter 872, Scott AFB, IL. The Conference Managers were MSgt Amber "AJ" Callahan and SSgt Nichole Brown. Below is a summary of events and the Conference Minutes.

Division 3 President Dale Lutzen called the meeting to order at 1:30 P.M. A quorum was present to conduct business.

The first order of business was to provide any convention manager updates to the Council.

Convention Manager Updates: MSgt Callahan welcomed everyone. She informed the Council that there were 7 Distinguished Guest baskets placed in the rooms of CMSAF#9 (ret) James Binnicker, International President Yeomans, Division 3 President Lutzen, and auxiliary past presidents (Ms. Elaine Savage, Ms. Kathryn Oden, Ms. Gloria Pinksaw, and Ms. Willa Hyde). MSgt Callahan also informed us that CMSAF#9 (ret) Binnicker will be joining us at our Saturday's business meeting.

#### **President's Report:**

- President Lutzen welcomed all present, and informed us that Division 3 is "alive and well" and it is "the place to be".
- Unfortunately, Don Sullivan was unable to attend this conference due to feeling a little under the weather.
- President Lutzen lauded Division 3 for being ranked first in retentions and ranked fifth in recruiting overall for 2013. Keep up the excellent work Division 3!

- President Lutzen thanked Chapter 984 for hosting an excellent convention last year, and is looking forward to this year's convention that is being hosted by Chapter 872.
- The 2013 International PAC was held in Houston Texas, and the 2014 International PAC will be held in Jacksonville, Florida.
- President Lutzen visited Minneapolis Chapter 858 last year
- President Lutzen currently serves on 2 committees: Awards and Communications committees. President Lutzen will continue to better their site on the Division 3 webpage and strive to be applicable to all mobile devices, along with being more accommodating.
- The AFSA mobile app is in place and user-friendly
- Medallions will be presented to the 2013 Division 3 Award Nominees to be worn throughout the conference
- Airman of the Year, NCO of the Year, Member of the Year, and Auxiliary Member of the Year will be announced at the Honor's Banquet on Saturday evening.
- The AFSA Association is strong and continues to persevere
- CAPWIZ: use it!! Approximately 49,207 CAPWIZ generated e-mails were sent during the fight to keep COLA
- There were no issues with the 2013 reports-"Good to go"

**Treasurer's Report by Treasurer MSgt Nick Melenka:** MSgt Nick Melenka stated our financial standing is good with \$6,199.66 in Checking and \$5,455 in Savings and an audit was completed in January. Division 3 received approximately \$3,238.75 for CY13 rebates. Charlie Dalzell motioned to approve the 2013 Budget; Steve Zalesky seconded, and the 2014 'roadmap' Budget was approved.

Awards by VP Steve Zalesky: This year 8 of the 13 Division Chapters submitted awards. We had 6 Airmen and 6 NCO nominees this year. The numbers of award submissions are comparable to last year, along with some Chapters not submitting any awards packages. He suspects this can be contributed to the lack of continuity as Chapter elections are held and new Chapter presidents take over. He will continue to review the awards process and assist with the Chapters that did not submit awards in building an awards continuity program. As the Division Executive Council, we need to remind our Chapter Presidents that the awards program is intended to formally recognize individual and Chapters' accomplishments; "Take care of your people." On a positive note, Division 3's awards program was clearly the best as we brought home the following awards for 2012:

Rallied for a 'murder board' to make award packages stronger before finalization, and will continue doing that in the future.

**Scholarships by Senior Advisor Charlie Dalzell:** This year was an overwhelming success for scholarship applications- there were 13 applications from 7 different states (MO-1; IL-3; WI-1; NE-2; SD-1; KS-1; and OK-4). The selection of scholarship recipients was influenced by completeness of replies, neatness, and legibility. The required areas of the

application were: high school/college transcripts, letter of recommendation from either a teacher, principal, or counselor, sponsor's address and AFSA Chapter number, high school/college address and phone number, and an essay. The essay played a major role in the committee's decision as the requirements were to answer the following:

- What do you think is the most important problem facing society today?
- Identify your problem and write an in-depth suggestion to solve the problem. This year's scholarship committee comprised of a retired teacher, a retired engineer, and a retired human resources individual.

**Membership by Terry Turner:** Division 3 Trustee Terry Turner provided statistics on Division 3's productivity and worldwide ranking in the following categories:

- Recruits: 1,717

- Retentions: 715

2013 was a productive year for Division 3. When we looked at the final totals, dedicated AFSA Recruiters and Retainers recruited 18,772 new members and retained 2,586 members.

Communications by Gary Swanson: 2012 was another great year for Division 3 Communications program, as Division 3 won 2012 Newsletter of the Year and 2012 Website of the Year. Division 3 will be another top competitor again for 2013. Many Divisions are turning up the heat and improving their website, but many are missing key mandatory items as required in AFSA manuals. There are 5 Chapters being hosted under the Division webhosting plan. In the future, we need to make sure to work better with the Chapters to ensure they know the minimums for the website requirements. The new theme was installed on the Division 3 website in January. - **4**th **Trustee Report by Roland "Bud" Kolwitz:** At last year's Division 3 PAC, President Lutzen tasked 4th Trustee "Bud" Kolwitz to work with the Chapters that had no membership activity. - 4) The President of Chapter 990 and "Bud" exchanged some e-mails and he indicated saying he wanted to handle their membership activities. Chapter 990 has very few dues paying members and a few retentions as well.

## **Communications Report:**

Trustee Gary Swanson expressed how important how 'Content is key'. 2012 was another great year for Division 3 Communications program, as Division 3 won 2012 Newsletter of the Year and 2012 Website of the Year. Division 3 will be another top competitor again for 2013. Many Divisions are turning up the heat and improving their website, but many are missing key mandatory items as required in AFSA manuals. - Secured \$30 mil in Impact Aid to school districts with high numbers of military children
- Created financial penalties for imposters who use false military identities/medals for financial gain
