3. Legislation:

- a. Meeting(s) with Senators and Representatives: Plan to visit with elected officials when they return to their home states and districts during congressional recesses ("work periods"). Call your local offices of these officials early in the year to determine when they plan to speak, provide town hall meetings, etc. Make sure chapter members are aware of such public meetings.
- **b.** Legislative Awareness Week (LAW): LAW is set of 1-7 October. This is AFSA's event to raise legislative awareness at the chapter level. Use this event to educate your members on legislative issues and how the legislative process happens.
- c. AFSA's Legislative Program: The Legislative Platform serves as the blueprint for AFSA's testimony and lobbying efforts, in addition to responses dictated by day-to-day events. The Platform is focused on issues that affect enlisted Airmen and their families, AFSA regularly meets with members of Congress and Air Force and government senior leaders to advocate for fair and equitable benefits that matter to today's Total Force Airmen and their families, and to our Veterans who have served proudly in the past. Pay raises, tuition assistance, healthcare, COLA adjustments, transition programs, care for survivors, and education benefits are just a few things on AFSA's legislative scope.

4. Membership:

- a. ALS Gradsuccess Program: Effective March 31, 2017, AFSA will end the one-year complimentary membership program. The intent of the program was to grow our membership numbers; however, our Association was not reaping the financial benefit from USAA sponsorship. If you recall some of my past emails on the state of AFSA and stated that we have two important issues; grow our membership base and improve on financial stability. This program did not improve our financial stability. The AFSA staff crunched the numbers and based on past historical numbers we have always been able to recruit at ALS and the loss of the \$36 membership rate did not make fiscal sense. This change is a great opportunity for our chapters. Chapters will regain membership credit for each member they recruit and there is financial benefit...\$5 for each new recruit. Chapters can easily earn around \$100-150 if they recruit 20-30 members per ALS.
- **b.** FTAC/Base Orientation/Right Start: It is extremely important to brief at these events to educate and recruit. Most importantly it is imperative that chapters attend these events to transfer members to the local chapter and add them to your distribution list. Link to transfer members:
