Administrative Information

Proposed By-Law Changes

The following AFSA International Bylaw changes will be considered during the upcoming International PAC in July. There are several important issues that will drastically change our organization so please take some time to review these changes. This listing is just a summary of some of the important changes. For more indepth information and a complete wording of the exact changes, please refer to the March/April 2011 edition of Sergeants Magazine.

Bylaw 4, Section 6: All members in bad standing will be dropped from the membership roles after their account is delinquent for 60 days.

Bylaw 4, Section 10d: This change will allow auxiliary members to enjoy all rights and privileges of AFSA Active Membership. Former Auxiliary members will be able to vote and hold office in AFSA. This bylaw change effectively ends the AFSA Auxiliary.

Bylaw 7, Section 2, Bylaw 10, Section 2, Bylaw 12, Section 2, and Bylaw 16: These bylaws will be deleted to complete the termination of the AFSA Auxiliary.

Bylaw 4, Section 3b1: Redefines AFSA Associate Membership and allows commissioned officers to vote and hold office in AFSA.

New Forms Available

HQ AFSA has recently redesigned the Activity and Americanism and also the Quarterly Financial reports. Ensure that you upgrade to the latest version and submit all future reports

using the new forms.

The forms can be downloaded from the HQ AFSA Website, <http://www.hqafsa.org>, by clicking the Resources tab, then selecting Forms.

You will have to be logged into the site to download the forms.

Dues Auto-Pay Option

For those of us that always seem to forget to renew our membership, AFSA is making it easier for you to ensure your membership is always in good standing.

Here is the official word from HQ AFSA.

Auto-Renewal of AFSA/Auxiliary Membership Effective May 1, 2011

1. New members may use the "auto-renewal" membership application (available on the web) to activate the membership auto-renewal feature. Existing members may also use the "auto-renewal" membership application to activate the membership auto-renewal feature. In both cases, the "auto-renewal" application must be mailed to HQ AFSA for processing, for maintenance of authorized signatures, and for financial and auditing purposes. All additional credit card charges will be applied during the member's anniversary month.
2. AFSA Headquarters will send each auto-renewal applicant a "notice of intent to renew existing membership using the original credit card," not earlier than 30-days prior to the member's anniversary date.
3. AFSA Headquarters will apply payments for renewed memberships not earlier than 10 days prior to the member's anniversary date.



Administrative Information

Dues Auto-Pay Option

Applicants will be placed in a "lapsed" status, beginning the first day of the following month, when credit card information can not be resolved.

4. Applicants may cancel their request for auto-renewal at any time prior to charges being placed with the bank (i.e., 10 days prior to member's anniversary date.) See AFSAM 100 -1, Section 8 and Section 11 for cancellations and refunds.

New Recruiter Forms

AFSA recently updated all of the recruiter forms to a new format. Please destroy all forms that are not in the new format. Any new recruits should complete the new documents to ensure all required data is captured.

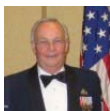

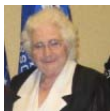

Legislative Update

TRICARE Increase

Your guess is as good as mine on how this will fall out. On 2 May, Military.com reported that the TRICARE increases were moving forward. During the week of 9 May both AFSA and Military.com reported that a House measure would block any increases to TRICARE. This week, 16 May, both AFSA and Military.com are reporting that the House Armed Services Committee is giving the go-ahead on the increases proposed by the Obama administration. If we stand any chance at all, we must contact our elected officials and let them know your vote is tied to their vote on this issue.

This is where we stand at this point; TRICARE Prime will increase by \$60/year for Family coverage or \$30/year for Individual coverage in FY12. Future increases are will be based on the annual increase in COLA so if we ever see a COLA increase again, a portion will be eroded by the increase in your TRICARE payment.

AFSA is watching this very closely but the organization needs you to contact your elected officials if we stand any chance of killing this effort.

Other Bills Of Interest

House Resolution 1283: Members of the reserve components can currently have their retirement age reduced from age 60 by three months for each stint of 90 days on active duty. While this change was a great improvement for reserve component personnel, all service had to be acquired within one fiscal year. If a reserve component member came onto active duty and part of their service crossed fiscal years, they would receive no credit for their service. Essentially, a member could spend 89 days in one fiscal year and 89 days in the subsequent fiscal year and receive no credit for time served on active duty. This law will correct this problem and be retroactive back to January 28, 2008, when the the age reduction bill was signed into law.

Senate Bill 472: To increase the mileage reimbursement rate for members of the armed services during permanent change of station and to authorize the transportation of additional motor vehicles of members on change of permanent station to or from nonforeign areas outside the continental United States.

House Resolution 1178: To amend title 10, United States Code, to extend military commissary and exchange store privileges to veterans with a compensable service-connected disability and to their dependents.

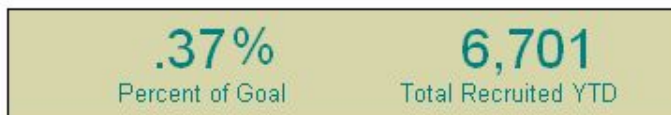

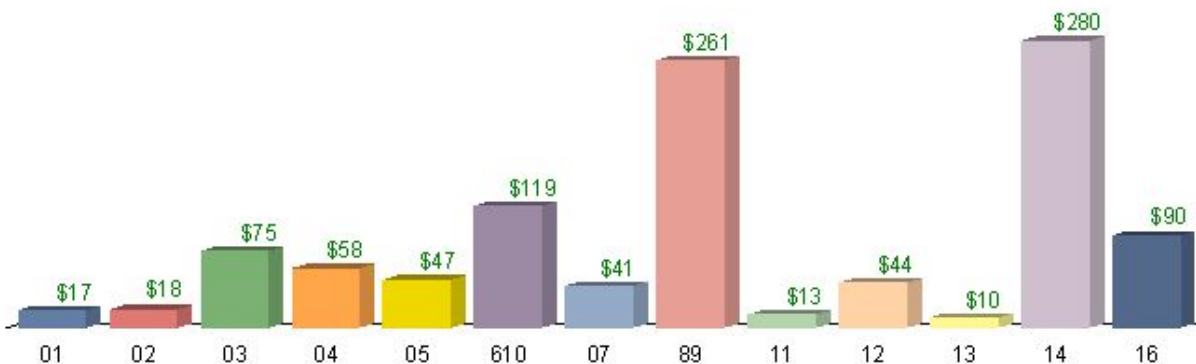
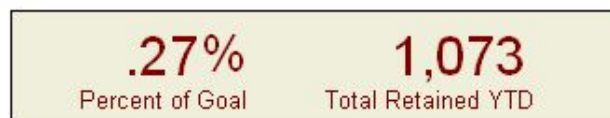


2011 REAL-TIME RECRUITING TRACKER
