### Happy New Year Division 89 Members!!

I and all the Division 89 Executive Council extend the heartiest greetings to you in this New Year. 2009 was a busy and most productive year, and we look forward to continuing that momentum! Although various plans to reorganize AFSA

were studied and rejected, we set an example by successfully merging Divisions 8 and 9. We did enlarge our borders to encompass 10 states as opposed to 5 each, but that was not the purpose. We maximized efficiency by eliminating an entire management level and related duplication, thus realizing a savings of half the cost to operate. We are completing our first year in this new posture and thrilled that our planning, execution and personal relationships have produced such positive results. As expected, it didn't change much of how we operate – business as usual!

<u>Division 89 PAC</u>: Chapter 951, Ellsworth AFB, SD will host our Division 89 Professional Airmen's Conference scheduled for April 29-May 1, 2010. I sent a finalized welcome letter containing the details and a registration form to all division officers and chapter presidents December 16, 2009 to disseminate to their members. <u>Awards:</u> Division Officers/Chapter Presidents should have received a letter, with AFSA Awards Guidelines and Change for 2009 attached, from Division 89 Vice President/Awards Chair Steve Zalesky. Although VP Zalesky will explain the submission process to you, it doesn't hurt to <u>emphasize that AFSA will not accept packages not in the proper format</u>. **ALL formats** have been changed since last year. The same guide will be used for packages submitted this year except for 2 changes: (1) The Chapter of the Year package will be a two page justification package versus having to attach all the reports you did last year, and (2) the Airman/NCO of the Year packages will require an "AFSA Contributions" category added to the 1206. It was decided we want to recognize AFSA achievers and not merely duplicate a similar Air Force award. I encourage you to please review closely the material that VP Zalesky sends you and submit your achievers to be recognized. As VP Zalesky receives award inputs, he will track them on the division website. **GEICO Affiliation Terminating March 1, 2010:** Recently CEO McCauslin sent the following message:

"Effective March 1, 2010 AFSA will no longer identify with GEICO products and services. A new contract will be effective that date and details will be briefed to the Executive Council during March meetings. Please distribute the aforementioned to all your chapters/divisions so there can be absolutely no solicitation nor eliciting of GEICO. This is a serious legal concern so your full support will be necessary. Thank You. Doc."

President Ledoux initiated this follow-up in response to some inquiries:

"As you know GEICO lost the contract with AFSA to another title sponsor who we expect will greatly benefit AFSA and our members. While we know some people will be upset, there's nothing AFSA will be able to do if GEICO



chooses to eliminate their discount after 1 March 2010. AFSA is expected to get a much bigger contribution from the new title sponsor than what GEICO provided...hence the change in sponsors.

After 1 March, we will have to eliminate GEICO from AFSA websites since the new contractor expects we will devote our attention to them. In addition, we should not solicit funds from GEICO or its affiliate offices after 1 March. If you talk to them before 1 March, I expect that would be okay...it's tough to cut the ties off immediately, but we have to do our best to ensure our new title sponsor is treated appropriately.

If you usually got some sponsorship money from GEICO for your conventions, you should probably look for another sponsor for your division convention. You might choose to increase your Ad costs to cover any loses you expect from this decision."

### Communications, Gary Swanson

If you are a regular reader of the newsletter and website you will most likely notice a few changes to both.

I received some very good feedback from a few folks around the division on the newsletter. There are two changes going into effect with this newsletter, the first is that we moved the text out closer to the margins, this will allow use to put more text on each page and reduce the total number of pages required for each edition.

The second change is that I will push a draft copy out to each of the chapter presidents to give them a couple of days to review to ensure that their input was properly captured. Our goal is to positively present all of our chapters to the entire AFSA community and with continual improvement of our newsletter and website, I think we will easily achieve this goal.



The website has seen some major improvements since last quarter. The first thing you will notice is that we have implemented a new template for the site. This not only "jazzed" up the place, but also gave us some new tools to dynamic information out on the front page.

Underneath the header image, you will notice three news blocks for Grassroots Efforts, Legislative News, and Division News. This is where all new news stories will appear as they are added to the site and gives you quick access to new items.

Another item that is being added is designed to get the word out about your chapter. When you pass on a news story to the division, it will also be added to the division webpage site for your chapter. This quarter, all of the chapter inputs for the division newsletter will also be available on your chapter page.

As always, our goal is to provide a website that contains continually updated material throughout the entire year.



Keeping the site updated isn't hard, the hard part is coming up with fresh news stories and blogs. We invite all AFSA Division 89 members that want to take an active role to volunteer and provide new content to the site to let us know. In closing I would like to add that our improvements have had a direct input on increased usage. We are now averaging over 200 unique visitors and 15,000 hits each month. We anticipate this improving even more during 2010.

### 3rd Trustee, Bud Kolwitz

As Division Trustee, two areas that DP Lutzen assigned me were the Chapters in Minnesota and Wisconsin. I have been working with Chapter 858, Minneapolis, MN and Chapter 859, Duluth, MN. There has been mixed results in that area. Also, I have been in contact with Wausau,





Chapter 856, and my own Chapter, Chapter 851, Milwaukee, WI.

Minneapolis, Chapter 858, was facing closure, but in working with one of their Chapter officers, it appears they will remain open. This officer got in past reports and they plan to have an election of officers in January or February and get a whole new slate of Chapter officers. Good for them!

But the downside is Duluth, Chapter 859. They are one of the oldest Chapters in the "old" Division 8. The President himself couldn't give AFSA the time he felt he should and letters went out to all the Chapter and Auxiliary members from him and the Auxiliary President asking if anyone would be willing to step up and be an officer or if the Chapter and/or Auxiliary should close. Unfortunately, when the responses came back only one person was willing to step up and be a Chapter officer. So, when they have their January meeting, the official announcement will be made as to whether or not they remain a Chapter. I am sorry to see them have to close.

Chapter 856, Wausau, has been talking to me about whether or not they can stay open due to the Chapter President's health these past few months.

One problem all the chapters have is getting younger members involved whether or not it is the AFSA chapter or the Auxiliary chapter. We have all discussed this and all acknowledge it is a problem. And if all AFSA members would get their spouses and/or family in the Auxiliary and both work together, it would help both sides. That is what has helped Milwaukee and Kansas City all these years.

Another problem is getting the local ANG base active in your Chapter activities. It is not "what you know, but **who** you know". Hit up that Base or Wing Commander, Vice Commander, CC, Chiefs, and 1<sup>st</sup> Sergeants and get them as members. Milwaukee has a good working relationship with the Guardsmen there. The Vice Commander, CC, and all but one 1<sup>st</sup> Sergeant are members. The ANGUS President is also a member. A joint AFSA/ Angus membership drive was held and another is planned. If you would like to talk to me about what we did, or how we did it, feel free to contact me.

Another responsibility which DP Lutzen gave me and which, admittedly, I dropped the ball on, was retentions. This next year I will do a better job of keeping all informed.

This has been a disappointing year for me in a way. A982, Lincoln, NE voted at their September meeting to close their Auxiliary. TRICARE Coming for Gray Area Reservists The FY2010 Defense Authorization Act provides premiumbased TRICARE coverage for "gray area" Guard and Reserve retirees who haven't yet attained age 60. The new program was authorized to begin on Oct. 1, 2009, but new TRICARE benefit changes typically take a year or more to implement because of contracting, system reprogramming and other requirements. A few weeks ago, TRI-CARE officials announced that they hope to expedite launch of what they've tentatively named "TRICARE Retired Reserve" coverage by late summer or early fall of 2010. Unlike the existing TRICARE Reserve Select (TRS) program - in which premiums are 72% subsidized by the government - gray area retirees will be responsible for paying premiums equal to the full cost of coverage. Although we won't know the exact cost of premiums until the program rules are published in the federal register. It will be considerably more expensive than TRS, the new TRICARE Retired Reserve benefit will provide gray area retirees and their families a competitive health care option when compared to the cost of private insurance, and allow for continuity of coverage under the TRICARE system.

H.R.3590, "The Patient Protection and Affordable Care Act" The Senate and House are planning to meet to discuss their versions of the health care reform and merge these bills into one version. Neither bill makes provisions to protect Veterans Affairs and Department of Defense health-care from the provisions of this legislation. Such protection would fulfill President Obama's promise made last August that neither program would "be affected by our efforts at broader health-care reform." Unless Tricare, Tricare for Life, and VA health care programs are exempted from a proposed excise tax, veterans and military retirees face the very real prospect of paying a new tax on so-called "Cadillac" health care plans, which Tricare and VA health-care might easily be considered. VA and TRICARE healthcare programs are earned benefits – earned through sacrifice and service and enacted by Congress that understands that taking care of veterans and military retirees is a cost of defending our nation. Not only would taking away these benefits break a promise made to those who served in the Uniformed Services, it would threaten the viability of the all-volunteer force because it breaks faith with those who serve based in part on the promises that were made to them when they signed up for duty. As has been pointed out by a number of federal employee labor unions, such a tax would "have a discriminatory impact on plans that cover older workers and retirees ..." Such excise tax could result in a tax increase of as much as 1.4% on veterans and military retirees and our widows, many of whom are retired on fixed incomes with no way to offset that additional tax other than by cutting

**Military Pay Raise:** President Obama has signed both the FY2010 National Defense Authorization Act (NDAA), in October, and the Defense Appropriations Act which authorized and funded a 3.4% pay raise for 2010.

**GI Bill Update:** The DoD released the 2010 Basic Allowance for Housing charts This is potentially big news for veterans using the Post-9/11 GI Bill because the housing stipend is directly tied to the BAH for an E-5 with dependents. Although some may see their GI Bill Living stipend increase by as much as 13.6% in 2010, the average increase will be more like 2.5%. Some may see no increase at all because the rates for 43% of the military housing areas covered by BAH will actually drop in 2010. The first question is, when will this new BAH rate go into effect for the GI Bill? Will it be increased in January or will they wait until July and increase it with the annual tuition and fee rate adjustment? Also, what will the VA do in cases where the local BAH has dropped? The DoD has a grandfathering policy that prevents the decrease of a BAH rate as long as the status of a servicemember remains unchanged. In the case of a veteran student this should mean that a current student will not see a decrease in their living stipend. Only new students or those changing their status would see the lower rate. As always, it seems there are more questions with the Post-9/11 GI Bill then there are answers.

War-zone Pay Now Pro-Rated The 2010 National Defense Authorization Act (NDAA) changed how special war zone pay is calculated and disbursed. Instead of servicemembers receiving full monthly payments for even one day's service in a combat or other danger zone, the Services now pro-rate these pays based on actual days of qualifying service each month. The special compensations include hostile fire pay, imminent danger pay, hazardous duty pay, assignment pay, and skill incentive pay, as well as associated tax breaks. The change was enacted to curb abuses, with allegations of servicemembers manipulating the system - even arranging mission schedules for personal benefit - reaching the ears of several lawmakers according to a Capitol Hill source.

**Membership, Terry Turner**, It was a great year for recruiting within Division 89. Our Division had 11% of the Skyhighers and 75% of the Highfliers for the entire AFSA organization. Additionally, Division 89 accounted for 9% of all new AFSA recruits and 35% of all retained AFSA members. These are outstanding numbers for one Division, keep up the great work in 2010.

I know that many of the chapters have their own websites hosted through a variety of companies. During the upcoming Division 89 PAC, I would like to meet with the chapters that currently have websites and those that are interested in developing websites and see if we can work out a hosting deal with one company to reduce hosting costs for everyone involved.

If you are interested in this, it would help if you could bring the following information.

- If you are running a static site or use a content managements system to include the CMS name/version
- Average bandwidth usage for a typical month

This is just to explore the potential use of a reseller account to reduce hosting costs for any chapters that would like to participate. If you are currently happy with your hosting services and cost, there is no need to participate.



## Air Force Enlisted Heritage Spotlight

Editor's Note: This month's spotlight is on CMSgt (ret) Dorothy Seidle, Chapter 804 President. I first met Dorothy during the Division PAC in Kansas City and it has been my pleasure to see her each year at our conventions. I find Dorothy's story very interesting since she attained our highest enlisted rank during a time when not that many females were able to do so. This article is in her own words and covers her service to our country, a 36 year journey. I hope you enjoy her story as much as I did.

### **CMSgt Dorothy Seidle**

It was 1952. I had just graduated from high school and had been a telephone operator at the local telephone company (part-time) since 11th grade. Family wanted me to go to college, but I had other unannounced plans for a career. However to compromise, I attended business college for 6 months, although I didn't like typing or shorthand as high school grades proved. In 1953, I went down to the Recruiting Station in Green Bay and applied for enlistment. Holy war broke out at home. Mom had had three sons to serve in WWII and Dad said girls in service didn't have a good reputation. (How would he know? We lived in a small town of 1200. and I didn't know of any girl who enlisted.) Persistence (and tears) won out and my folks went down to the Notary Public at the Post Office and signed papers so I could join the Army.

Another problem arose. I had to lose weight. I TRIED, but thank goodness the recruiters were desperate, I guess, and my weight was waivered. In October 1953, reported to Milwaukee, had a physical, etc., and was put on a train to Fort Lee, VA for 8 weeks of basic training. (I still believe every kid should go through this training.)

Following Christmas leave, I met a fellow WAC from basic in DC and we traveled by train to our first assignment -- Fort Ritchie MD. Shortly after arriving, she and I were shown the switchboard since we had the experience of being telephone operators in prior life. The OIC asked if either of us could type and from then on, I was a typist for the rest of my career.

Fort Ritchie was a neat place. It was a very small post and served as an alternate Pentagon in case of

an attack on Washington. I remember a time, during an exercise, that President Eisenhower arrived in the "mountain," and while everyone else was standing at attention and saluting, I stood there with my mouth open. Our uniforms were starched cotton dresses and I thought a crinoline slip (remember those, ladies?) would minimize wrinkles. It was noticed and disapproved of when we fell out for formation the first time. Then, I bought a pair of snakeskin pumps, which didn't need polishing. They also were frowned upon and had to be removed. Then there was a little joke three of us played on our First Sergeant (who was up in years), but that's another story. A year or so later, I hurried back to the barracks from work to get to town and purchase airline tickets for a surprise trip home. In my haste to avoid standing Retreat, I fell on the orderly room steps and broke my elbow, Spent the next week at Carlisle Barracks and another post hospital that I can't remember.

Doesn't this all figure that I got a call at work one day from the WAC commander asking if I'd be interested in going to OCS. By that time, I had met the "love of my life" and wanted an overseas assignment since he was being reassigned to Formosa/Taiwan. About that time, a "freeze" was placed on all personnel actions. When requested again, I got orders to Okinawa and was on my way - driving my first car across country to Seattle WA. Stopped at home in WI and promised my uncle that I would not pick up any hitchhikers. There were stories of bad men dressing up in uniform and hitchhiking. Sure enough, somewhere I drove by a soldier and felt guilty for not stopping. Even stopped up the road a piece and flipped a coin. Two out of three times indicated that I should not. Never forgot and still feel badly about passing up possibly a fellow soldier in need of a ride.

In 1957, having been on the Island of Okinawa several months, two other girls and I hopped a ride on the Soldier of the Month flight to Hong Kong, stopping in Taiwan on the way. Boyfriend met us. We three gals had a great time in Hong Kong, having jewelry and clothes made. When we ran out of money, we shared a meal three ways and called Mom (collect) for a loan. The returning flight was cancelled because of a flu epidemic and we used the

last of the money to wire our NCOIC for a leave extension. The reply came back and read disapproved." We turned ourselves in to the American Consulate and they arranged for us to fly back on a commercial plane and pay for the ticket on payday. Upon return, we met our NCOIC who asked what we were doing back already. He laughed and said he had us covered and just didn't want us to spend all of our money. We could have clobbered him.

When my boyfriend came to Okinawa on leave, we made plans to get married. I applied for curtailment of Foreign Service and return to the US with my husband. That was disapproved. I requested a transfer to Taiwan and he was going to extend there. That, too, was disapproved. I requested a compassionate transfer, but at that time, the military only granted those to men. When I requested discharge on grounds of marriage, it was approved. By the way, we were married by the mayor of Naha. Thanks to my friend who worked in Transportation, arrangements were made for my husband and me to share a cabin on the Army transport ship to Oakland.

Shortly after arriving in St. Louis for our next assignment, I inquired about getting into the Reserves and was told that they were not accepting women. So I got a typing job as GS-3 in Internal Revenue. When I applied for promotion in the Army contracting office, was told that they didn't hire dependents because we wouldn't be there very long. Since we hadn't been there even a year, I assured them I'd be there for sometime and got the job. Three months later, my husband had orders for Hawaii. After 3 years there, 2 years at Fort Detrick MD, and 9 or so months in Japan, we were stationed at Scott AFB and I worked in EMO (supply). Newly divorced with four children to support, I accepted the position in the AFCS History Office with the understanding that the Service was moving to Richards-Gebaur AFB

In August 1970 (on the hottest day of the year), the children, pets, and I drove in a non-airconditoned car to our new home in Missouri. The kitten barely

made it; the fish died. R-G AFB was a small base and soon we got to know most everyone. A civilian personnel newsletter was distributed to our office and an article said that the Air Force Reserve wants "you." We talked about it and I said they didn't want me. I was too old and had four children. My boss suggested I try, which I did, and was accepted at the same rank (E-5) that I left active duty with 15 years earlier. Had a family meeting and explained to the kids what being in the Reserves would mean -- UTAs, annual tours, extra income, etc. They approved. When I went home for lunch during the first UTA, they were lined up in the driveway and saluted, and I knew I had it made.

In 1976, I was recruited into AFSA and was now in a very active and respected chapter -- Chapter 504, later Chapter 804. In 1985, I was honored to be elected President of the chapter -- the first Reservist and the first woman to do so in this chapter.

The time following the news that AFCC was going to move back to Scott AFB was very traumatic. The family and I wanted to stay in Belton and fortunately I got an Air Reserve Technician (ART) position with the 442 Tactical Airlift Wing. When the dust settled, the Reserves acquired another base -- Richards-Gebaur. In 1980, I got the job as Chief, Base Administration; responsible for mail, PDO, Master Library, special orders, performing staff assist visits to our subordinate units in other states, training of administrative reservists, etc. It was the best, most diversified and challenging job (outside of mother-hood) that I ever had. I retired from the reserves and civil service in March 1989. I had been truly blessed.


