AFSA Membership

After nearly 13 years unchanged, membership dues are going up. Much of this is due to the increased costs of defending our benefits and servicing AFSA's members. While the increase might seem significant, it is still on par if not cheaper than other organizations such as ours. The new

rates are: 1-Year—\$36

2-Year-\$69

3 Year—\$89

Greetings from your Division 3 President, Each New Year comes with renewed challenges and opportunities. As we say goodbye to 2015, I'm optimistic about the prospects of the coming year and am looking forward to achieving new goals for our division. This next year will bring many challenges with membership recruiting, legislative challenges, chapter growth,

and development. In case you have not already heard, last month the AFSA International Exec Council had to make some difficult decisions, which resulted in the raising of membership dues.

First off, membership is a critical revenue steam that AFSA relies on, therefore to ensure the survivability of our Association we MUST recruit/retain over 22K members in 2016. We have some work to do if we are going to attain this goal...we need everyone to be all-in! The 5 years for \$25 membership incentive did not achieve the expectations that everyone had hoped it would do. AFSA took a financial risk in offering this incentive. Despite an increasing cost of doing business, dues have remained unchanged since 2003. For 2016, membership dues rates will change to 1-yr-\$36, 2-yrs-\$69, and 3-yrs-\$89. You may be surprised at the dues rate increase, but keep in mind AFSA dues rate is lower than many other military/ veteran service organizations. We need every member to do more and get more involved in your chapter recruiting activities.

Do you have a dependent who is about to graduate high school or is currently attending college? IF so, the AFSAA and the Airmen Memorial Foundation (AMF) joined together to conduct a scholarship program to financially assist the undergraduate studies of eligible, dependent

children of the enlisted AF members. AFSA, AMF (including the CMSAF Scholarship Program), and AFSA International Auxiliary award awards scholarships valued from \$500 to \$3,000 to students attending an accredited academic institution. The grant amount and total number of scholarships awarded are dependent upon funds available. To date, over \$1.9 million dollars in scholarships have been awarded to AF dependent children. Applications for the upcoming academic year are available from Jan. 1 to March 31. Remembering Where we Came From; Knowing Where We Are Going

Prior to the formation of the Air Force Sergeants Association (AFSA), Air Force enlisted personnel did not have an independent voice capable of influencing legislation and governmental policies. This came at a time when Congress was questioning its promises to service members about education benefits, health care, pay, and a fair quality of life—all while we were waging a Cold War.

During the post-Korean War era U.S. Armed Services were cut to the bone and attacks upon the military by members of Congress, the press, and even the

American public resulted in promotion freezes, low pay and allowances, inadequate housing, and many other inequities.

Life in the military was rough and much unappreciated. Enlisted life was the roughest. Many enlisted personnel began to talk about starting an association and DOD feared the unions would try to get involved. Of course unionization was not an option; but there remained the needs to educate lawmakers about enlisted life. Four enlisted visionaries from Bolling AFB, DC, decided to accept the challenge.

MSgt Benny W. McGehee, TSgt Virgil Perry, SSgt Donald Ward and TSgt Lee Thompson applied to the District of Columbia for a charter as a non-profit association, which was approved on May 3, 1961. At that time, they applied to the Internal Revenue Service for tax-exempt status.

The IRS tax exemption was granted under Section 501 (c)(4) of the Internal Revenue Code. In 1975, AFSA received a determination from the IRS and the U.S. Postal Service that AFSA was essentially a —war veterans organization within the meaning of Section 170 (c) (3) of the Internal Revenue Code. As a result of this determination, AFSA applied to the IRS and received approval for tax exemption under Section 501 (c) (19) of the Internal Revenue Code.

Today, AFSA is a fully recognized professional military organization that is highly respected in White House, on Capitol Hill, and in the Pentagon.

Also you can publicize your event on Facebook. Create it with all the information/attachments needed and once it is posted it goes out to the public and/or people you invite. Another good thing is every time you make an update or addition to the event it goes out to everyone signed up. Chapter 951 used this last year to publicize the Division 3 Convention.







Building Bridges

For an association such as AFSA to be as effective as possible, the local chapter must be engaged with the various private organizations on base (Airman's Council, NCO Council, Top-III, Chiefs Group, First Sergeants Council, Company Grade Officers Council, and of course the Enlisted, Officer, & Civilian Spouses Councils). What we often overlook is connecting with the base leadership (Commander, Command Chief, Executive Officer, Protocol, Public Affairs, & Judge Advocate) as well. Building that bridge can be as simple as sprucing up the existing bridge, or starting from scratch as we've recently had to do here at Ellsworth.







Within two weeks of assuming command in June, the chapter executive council met with the new wing commander to brief him on what the chapter was doing and to hopefully get him to join AFSA. The 2-year cyber membership was available at the time and we pitched it to him; he declined...and we all

felt the breath leave our bodies. But what he said next gave us hope: "I want to get the AFSA magazine, I want it on my coffee table in the front office so everyone who visits know that I believe in organizations such as AFSA and that I am a member!" Wow, what a positive feeling that was!

At the time we were in the midst of our first big community events, the second annual Honoring Our Patriots concert and first annual POW/MIA 5K Run/Walk. After zero base support for an "AFSA-led" POW/MIA event the previous year we seized the opportunity to commemorate and honor our POW/MIA comrades in downtown Rapid City. The concert started in out in 2014 with a simple combined honor guard lowering and folding the colors during an existing concert; that event raised \$1000 which we donated to the Wounded Warrior Project. For the second concert we expanded our fundraising to include raffles, food sales, and once again a combined honor guard. Initially we had interest from all the private organizations on base, but lacking any advocacy from the base leadership it soon became just a small core of engaged volunteers; most from the Chapter.



We did not let this stop us we pressed on, raising over \$9300 for The Gary Sinise Foundation, Intrepid Fallen Heroes Fund, Air Force Assistance Fund and with over one-fourth split (fair-shared) between all the participating organizations. Doing the largest burden the Chapter earned over \$1200, while two private orgs who quit each received a check for \$10.



We've built a bridge with the new wing commander, now it was time to do the same with the new wing command chief. The first thing we did when we got the name was to look her up to see if she was an AFSA member...and YES she was! (unlike the last two). Even better, in her biography it was noted she was a former AFSA First Term Airman of the Year! (things are looking up). We sent her a welcoming email, a copy of our chapter informational tri-fold with an invitation to looking forward to working with to support the Airmen of Team Ellsworth.

Next came a quick meeting with the Chief to layout our upcoming concert and 5K events, unfortunately she already had TDYs scheduled for both days but she was impressed and wanted to hear the results. Well, here is where patience and letting things happen on their own can pay off...I met with her, showed her all the financials to include how much each of the private orgs participated (time and raffle tickets sold) along with each org's fair-share of the proceeds. It was easy to see that we did not have a "team" working together.

So, where are we at now as we're planning the 3rd annual concert and 2nd annual run/walk? We've received assurances from each private org that they will be involved and engaged. Sometimes you have let folks "make their own bed and lie in it" to make a point. While raising over \$9300 was a success it was a third of what could have been raised; had we gotten the full support and engagement from each organization.

To build that bridge chapter members need to be visual, vocal, and pro-active. If you're at a Top-III or Airman's Council meeting take a minute and inform your fellow member what the AFSA chapter is doing. Drinking your coffee out of an AFSA coffee cup is one way to start a dialogue in the work center. Will you encounter a nay-sayer...YES! Smile and move forward; if that person is truly open-minded and a true Airman they'll come on board later.

To build that bridge with your base leadership you will need to walk carefully. It is much easier for some on base to say "No" rather than say "Sounds interesting, let me look into it." During the staffing process for our raffles I was told by JA that state law limited our raffle to a prize not to exceed \$2000...I found this funny since we were raffling off a \$12,000 motorcycle and had already received approval from both the city and county attorney's office. A quick check of the state statutes (Google is good!) found me the answer: the \$2000 limit applies to a single Bingo game. A simple follow up email (no gloating!) with the JA and our raffles were all approved.

Quite a long story, I know. But a year ago our situation looked hopeless. But that situation did not occur overnight, nor will it be overturned overnight. Patience, persistence, resolution, and most of all optimism will be your guide. lic.




Also during this event our chapter, working with several of the local and Ellsworth Private Military Organizations, continued to sell raffle tickets for the Victory Motorcy-






AFSA Chapter 964 put on the first Lip Sync Battle at Grand Forks Air Force Base.


