CAPWIZ is also an excellent research tool so you can find out what is happening on Capitol Hill and most importantly, find out if your elected officials are looking out for your best interests.

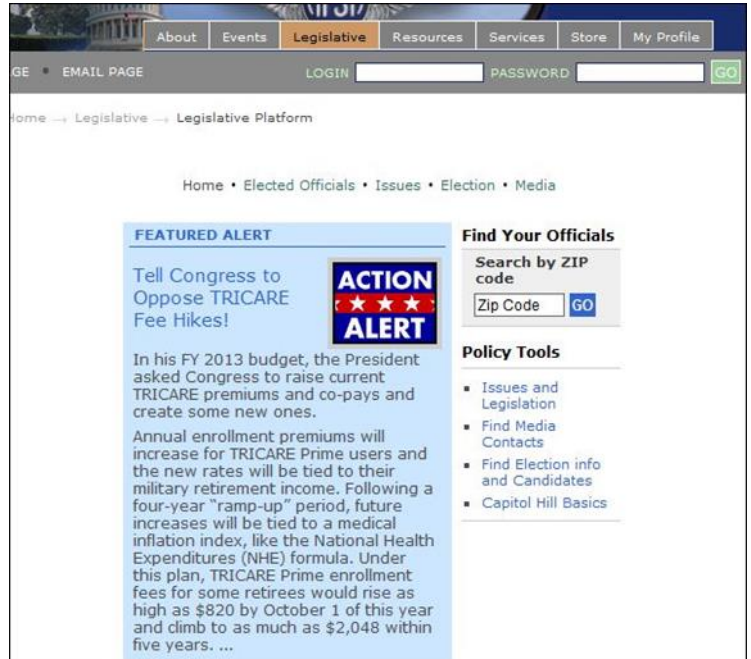

## What can I do on CAPWIZ?

- Send an email to your elected officials about an issue that is important to you
- Research candidates for public office at the state and federal level
- Research federal government agencies
- Research all legislation currently before congress
- Sign up to receive voting records for your elected officials
- Learn basic etiquette for contacting Congress
- Follow political races for each state and the federal government
- Register to Vote
- Contact local media outlets to let inform the public on matters concerning the enlisted Airman

If our organization is going to be successful in our lobbying efforts, our membership must be proactive and contact their elected officials. If we do not actively engage our politicians, we run the risk of losing key benefits won during the last 40 years.

- Click on Send Message

### Chapter 985



February 13. President Terry Turner and VP (Elect) Zach Merkl briefed 15 NCOPE attendees on legislative activity and AFSA goals and objectives. ## Legislative Update

Well it's officially silly season in Washington D.C. as elected officials focus on the November elections and get to work on the President's budget proposal for FY2015. As it has been for the past 6 years, the President's budget was dead on arrival in both the House and the Senate because it was not a serious proposal intended to deal with the nation's fiscal challenges. This was particularly true of the President's FY2015 National Defense Budget request.

The President's defense budget proposal made the argument that our active duty military make too much money and thus their benefits must be slashed and the President proposed capping military pay-raises at 1% for FY15 & FY16. It proposed slowing the growth of BAH to a cap of 95% coverage leaving the last 5% to come out of the Airman's pocket.

His budget would drastically reduce Commissary subsidies which would in effect result in stateside Commissaries closing. The President once again proposed the Chained Consumer Price Index – 1% (CPI-1%) be used to determine Cost of Living Allowance (COLA) rates for military retirees. His budget also proposed consolidating Tricare Standard, Tricare Extra, and Tricare Prime into one fee for service plan.

Tricare proposals made by the President would also include annual enrollment fees and higher deductibles and for the first time would require family members of active duty and military retirees using the Military Treatment Facility to pay a deductible. The net outcome of these proposals would have resulted in a cost share for retirees of 11% of their total healthcare costs.

The good news is that we still have a Congress that must sort all of this out and so far the House of Representatives is proving once again that they value the courage, sacrifice and commitment of today's warriors and our military retiree community.

As outlined in H.R. 4435, The 2015 National Defense Authorization Act (NDAA) rejects all of these proposals except the proposal to reduce the subsidy for the Commissary. The bill does provide for a \$100 million reduction in appropriations for Commissaries but it is too

early to tell what that will mean for the future of stateside Commissaries. Rest assured your AFSA advocates are watching this development closely. The other piece of bad news in H.R. 4435 is that it doesn't specifically address the pay-raise for active duty personnel which means that the President will be free to limit it once again to 1% if he chooses to do so. We can always hope that the Senate bill will address this but I wouldn't hold my breath.

As far as the Senate goes...well...that is another story all together because Senate Majority Leader Harry Reid has demonstrated time and time again that he intends to carry the President's water on budgetary issues so we will just have to wait and see. For now though I am fairly confident that the vast majority of the President's proposals will be defeated by the time conference committees meet to hammer out the final NDAA in the fall.

So what can you do about all of this? First you can stay informed and help your friends and family understand what is at stake during these budget negotiations. Secondly, use CAPWIZ early and often and let your elected officials know you are engaged and that you will hold them accountable for their votes. Lastly, stay strong and don't become discouraged by the political nonsense on Capitol Hill.

The American politic can change dramatically with one election and there is a very important one coming in November. If each of us exercises our right to vote and cast ballots for politicians who share our values we can make a difference. The days of sitting out an election or two are long since past because every election matters and our future as an Air Force and our future benefits hang in the balance.

Stay strong, make your voice heard and continue to hold the line. Thanks for all you do and for your continued advocacy for our Air Force and our Airmen and their families both past and present.

## The Mission Isn't Over

If you are looking for patriotic and dedicated leaders...look at the Air Force Sergeant's Association! I recently had the privilege of being the keynote speaker at the AFSA, Division-3 annual conference. After my speech, I sat-in on several very informative briefings, such as: TRICARE, legislative affairs, and comments by the AFSA International President, Mr. Dan Yeomans. I also had the distinct honor of meeting and exchanging career stories with several other AFSA members, retired and active duty. AFSA members Bud and Jean Kolwitz, Harry McLane, Steve Zalesky, Amber Callahan, Mike Thyne, Evan Rios and Briana Stanley were just a few of the great American Airmen with whom I spoke.

Over the course of the day, it quickly became apparent the briefers and attendees were on a mission. Although their mission will no longer take them into harm's way or require heroic actions...it does take enormous confidence and courage to champion initiatives that "protect" the pay and benefits of military personnel, veterans and retirees. Since 9/11, more than 2.5 million patriotic warriors have served in our military. Two million of those 2.5 million have served with valor and distinction in Iraq or Afghanistan. Plus, let us remember the men and women that served so proudly in the Korean War, World War I, World War II, Vietnam War, and Persian Gulf War. They took the same oath of enlistment those in uniform today take...swearing or affirming to protect and defend the Constitution of the United States against all enemies, foreign and domestic. And you can rest assured they lived up to that oath. *They never faltered and they did not fail.* Thousands gave their lives and thousands more returned home so severely injured even their own children cannot recognize them. So I want to boldly say, "active duty, guardsmen, reservist, veterans, retirees, spouses and dependents have earned and deserve every penny and every benefit our National leaders have "promised" and bestowed upon them." A breach of that promise constitutes a breach of integrity.

Daily we read and hear media say, "the war is over," in Afghanistan and Iraq. Let me be very clear...don't confuse "war" with "mission"...the mission is not over! Around the world terrorists continue planning their next attack on American interests and resources. As tension continues to escalate between Russia, the US and our European allies over Ukraine, one must ask, will that become our next military challenge? Could a successful attack on our critical infrastructure cause a collapse in our economy and threaten national security? With everything at stake, I acquiesce now is not



the time to consider cutting or reducing military pay and benefits. Let the Military Compensation and Retirement Modernization Commission (MCRMC) do its research and report their findings and recommendations on 1 February 2015. I have confidence they will advise Congress and the President to seek other options to better manage their spending strategies and reduce the national deficit. I also believe they will advise leaders in Washington to ensure future legislation regarding military compensation includes a parachute or grandfather clause that protects those currently serving or retired. If we want to truly preserve our war fighting capability, we must protect the high morale and quality of life for our nation's greatest weapon system....our military men and women!

From "Strength-In-Numbers" AFSA is better postured to persuade others and debate the issues that impact pay, benefits and quality of life. Here's just a small sampling of what's potentially at stake over the next twenty-four months: Leaders want to cap the allowance until average BAH covers 95% of rent and utilities; BAH will no longer cover renter's insurance; Dependents and working-age retirees would face higher costs for healthcare; Tricare co-pays would increase, and annual cost of living rates will not keep pace with inflation.

Everything I just mentioned has the prospect of taking money out-of-the-pockets of active duty, guard, reserves, retirees, veterans and/or dependents...and that's just wrong! But don't get annoyed just yet, there's more. Food stamp redemption at military grocers has been rising steadily since the beginning of the recession in 2008. Nearly \$104 million worth of food stamps was redeemed at military commissaries in the fiscal year 2013. I think (as do the many Americans) it's unacceptable for Soldiers, Sailors, Airmen or Marines to require food stamps as a parachute income to offset low



basic pay and allowances.

As I mentioned earlier in the article, many brave Americans have given life and or limb to serve under the American flag, so the other 99% of the nation can sleep in peace, knowing that when they awake their freedoms and quality of life will not be interrupted. So, who are these brave Americans that provide constant vigilance? Let's call them the American sheep dogs or guardians of the flag. The sheep dog is always on alert, for they know predators are always just around the next turn. The sheepdog possesses a *capacity for courage* to drive the streets of Iraq in the face of snipers or roadside bombs. They give meaning to the words "service before self" when they put on full battle gear and stand guard at a fire-base in Afghanistan. And when the predator attacks or the shooting starts, the sheepdog doesn't run away from the gunfire. They run into the fire! The sheepdog will die for someone they don't even know, even if that someone lives half way around the world. Why, you ask, would the sheepdog do this? They know that if nobody stands up to the predator when challenged, soon our flag and ideals of freedom will fall.

### Chief Turns 55

The year 2014 marks the 55<sup>th</sup> anniversary of the United States Air Force's highest enlisted rank: chief master sergeant. The United States Congress created the "super grades" of E-8 and E-9 as a part of the Career Compensation Act of 1958 and decreed that a maximum of 1% of the enlisted force could be in pay grade E-9 along with a maximum of 2% in pay grade E-8. The basic law directed the minimal time in service eligibility requirements of 8 years to E-8 and 10 years to E-9. The Air Force opted to increase the minimum time in service requirements to 10 years for consideration for promotion to E-8 and 11 years service to E-9 respectfully.

The Air Force also required that the eligible Master Sergeants take and pass a written supervisory test with a percentile score of 90 or more. Since no such supervisory test had been

written for this purpose, the supervisory portion of the Warrant Officer test was used. On 1 September 1958, 2,000 Master Sergeants were promoted to Senior Master Sergeant. On 1 March 1959, a second group of 3,000 Master Sergeants were promoted to Senior Master Sergeant.

Late in 1959, these 5,000 SMSgts competed at Command-level Boards. Six hundred and twenty-five were selected for the first increment of promotions to the rank of Chief Master Sergeant. There were no line numbers at that time so all 625 were promoted on 1 Dec 1959 and share a common date of rank. These men came to be known as the "Charter Chiefs."

The greatest number of promotions went to the aircraft maintenance career fields. The small total number of promotions meant that there were typically only one or two Chiefs at each base. The new Chief was treated more with curiosity than anything else. They were the movers and the shakers who had already gravitated to the more responsible positions, so most continued on in the same jobs they had held as Master Sergeants. In fact, the official term of address continued to be Sergeant.

The Charter Chiefs continued to serve with dignity and established the highest standards of leadership. They forged the ground rules for Chiefs to come. As additional Chiefs were added to the ranks, Chiefs Groups came into being. Still addressed as Sergeant, they petitioned the Air Force to be called Chief, but to no avail. In fact, when the first CMSAF (CMSAF Paul Wesley Airey) came on the scene, he was still formally addressed as Sergeant Airey. Finally, in the mid-1970's "Chief" became the accepted term of address.

Of the original 625 Charter Chiefs, less than five percent are still alive. Their average age is 91, with the oldest being 98. Their last formal gathering was at the 50<sup>th</sup> Anniversary celebration in held in December of 2009 at Barksdale AFB, Louisiana.
